



## Mid-Session Update: Mixed Bag for Good Food and Farm Policies

### Farm-to-School Program Faces Major Cuts

The 2017 Oregon Legislative session reached its halfway mark in mid-April, and state legislators continue to grapple with a massive \$1.6 billion funding shortfall. As a result, many funding priorities and legislative proposals important for healthy local food systems and family farms are at risk.

As of the April 18 deadline for action on most legislation, a number of bills Friends of Family Farmers supported had died, while some remained in play. In short, legislation to curb air pollution from a growing number of mega-dairies in Oregon was tabled, as was a bill to restore local control over problematic genetically engineered crops. But a few key bills are still in play, including:

**HB 2739** - legislation to hold patent-holders of genetically engineered crops financially liable when their products cause problems for farmers

**HB 2085** - a bill to create a beginning farmer tax credit - currently in the House Revenue Committee

**HB 2038** - legislation to fund Oregon's Farm-to-School program at current levels for another two years - currently in the Joint Ways and Means Committee

**SB 805** - legislation to protect 2015 funding increases and maintain current service levels for OSU Extension and Ag Experiment Stations - currently in the Joint Ways and Means Committee

However, in late April, top legislative budget writers proposed a number of steep cuts if new revenue is not found. **Under the proposal, Oregon's Farm-to-School Program would receive no funding at all.** Farm-to-School, a small part of the state's overall budget, incentivizes schools across the state to buy local produce for school meal programs, providing kids with healthy, locally grown food and farmers with new sales opportunities.

Now is a critical time to raise your voice to your state legislators and urge them to maintain current funding levels for Oregon's Farm-to-School Program. **Write and call your State Legislators today. Every call and email makes a difference!**

Currently, over 900 people all over the state have joined Oregon Farm Link to list available land, seek land to start a new farm, or to post job openings at existing farms.
